Discuss & Vote on Math Curriculum not to exceed \$15,000 – Angelee Spader stated that the school received a grant from the STEM Action Center for supplement online math program (iReady). Ready math allows students to move through the standards at their own pace. After looking into whole Ready math curriculum, the administration decided to use the curriculum schoolwide. The math curriculum we have been using is five years old. Ready math is an up-to-date curriculum. Penn Bradshaw made a motion to approve the Curriculum Associates purchase for Ready Math curriculum not to exceed \$15,000. Kristin Schill seconded the motion. The votes were as follows:

Discuss & Vote on Technology purchase not to exceed \$11,000 - Dave Bullock stated that the school received about \$8,000 more of SLT funds for this year. They decided in the SLT committee that if they received more money that they would use it to purchase more Chromebooks for K-5. Michele Kersey Smith made a motion to approve the technology purchase for an additional Chromebook cart not to exceed \$11,000. Brittney Hale seconded the motion. The votes were as follows:

Jade reviewed the budget as of July 31st. Jade also mentioned that the FY2018 audit is on-going at this time with Eide Bailly. We are looking really good.
