Discuss and Vote on Human Sexuality Curriculum – Vicki stated that the health curriculum that Ms. Kucharski will be teaching this year is virtually the same curriculum that was approved last year. Vicki brought an outline of Ms. K's the lessons that she is planning on teaching as well as the text book she is using in the class for the board to review. ▶ <u>Discussion & Update on the use of "Teach Like A Champion"</u> – Dave briefly review the implementation of "Teach Like A Champion". Dave stated that when he came on the teachers were already meeting to review the book. The administration felt they should focus on classroom management. The first skill that they implemented was "100 Percent". Some of the other skills that they have reviewed this year have been "What to Do", "Do It Again", "Strong Voice", "Sweat the Details", "Threshold", "No Warnings". They will have reviewed a total of eight skills this year out of a total of 48. The administration will plan next year's skills this summer. Dave stated that each month as they do observations, they are looking to see if the teachers are implementing the skill for that month. The teachers are sharing what they are doing. There was a discussion on the difference and progress these skills are making on school wide. This is becoming a cultural thing for Quest Academy.
