• <u>Discuss Board Transition</u> – Steve Reeve wanted to discuss the key issues to navigate the transitions. He asked Gabe Clark to lead this discussion. Gabe stated that the board needs to appoint board officers which is on the agenda. There was a discussion on board composition; board members; terms; policy amendments; and training.

 <u>Review 2018-2019 Budget as of Sept. 30, 2018</u> – Gabe Clark stated that Ryan and Dave have had a couple of S&P calls. Dave stated

that he received the report today and the school did receive a BBB-rating. Gabe also mentioned that we are in the last stages of the audit. If the board would like the auditors to come and present to just let Ryan know. Gabe reviewed the 2018-2019 budget. We are up 90 students from last year according to the October 1 count. Gabe pointed out a few areas of interest.

> Administration

- *State of the School* Dr. Dave Bullock
 - ✓ Started to serve breakfast this month and it has been very good but we expect numbers to grow
 - ✓ Canned Food Drive has started until November 1st
 - ✓ Dr. Dave whole heartedly thanked all of the parents and teachers that are in attendance tonight including the board. He is never been prouder of being here. We are stronger together.
- Review of SAGE Scores Dave reviewed the ELA, Math and Science scores in elementary with comparisons regarding surrounding schools. He also reviewed the new curriculum that they are using this year. Nicki reviewed the jr. high scores in ELA, Math and Science. Two years ago, our scores were well below the state and surrounding schools. Nicki has worked really hard with the teachers by meeting every week on individual students and what is working and what is not working. This last year's scores exceeded the state average.
- <u>Update on "Teach Like A Champion"</u> Dr. Dave Bullock gave an update on how they are doing their TLC training with teachers. New teachers are required to do the TLC training however they don't require the veteran teachers to attend but if they want a refreshers they are welcome to attend.

for the work and effort that they have accomplished for the school during their time and tenure.

- Discuss & Vote on Board Officers Steve Reeve led a discussion on filling the board officers. They really need at least a board president and financial coordinator. Brittney Hale made a motion to appoint Steve Reeve as the Board President; Brittney Hale as the Vice President; Michele Kersey Smith as the Treasurer and Nicole Weighall as the Board Secretary. Michele Kersey Smith seconded the motion. Motion passed unanimously.
- Discuss & Vote on Utah Grants Application and Utah Consolidate Application Plan - Dr. Dave Bullock reviewed the UCA. This is for federal and state monies that we are required to report how the school is going to spend the funds. We will be using these funds for salaries. Michele Kersey Smith made a motion to approve the Utah Grants Application and Utah Consolidated Application Plan. Brittney Hale seconded the motion. Motion passed unanimously.
- Discuss & Vote on Parent & Family Engagement Policy and Rescind the Parent Involvement Policy Dr. Dave Bullock reviewed the Parent & Family Engagement Policy. This policy replaces the current Parent Involvement Policy under to the "Every Student Succeeds" Act due to the school receiving Title I funds. The Parent Involvement Policy was under the "No Child Left Behind" Act. This policy template was sent to us by USBE.

 Michele Kersey Smith made a motion to approve the Parent & Family Engagement Policy and rescind the Parent Involvement Policy.

 Brittney Hale seconded the motion. Motion passed unanimously.
- Discuss & Vote on Dress Code Policy and rescind the Uniform Policy Angelee Spader stated that this policy was written over 10 years ago. The administration has had many parents, students and teachers requests for changes on the policy. Angelee reviewed the changes that include wearing QA logo clothing (sold by the school) on any day, spirit shirts are not required to be tucked in; and hooded garments are allowed on free dress day as long as hood is not worn in the building. Michele Kersey Smith made a motion to approve the Dress Code Policy and rescind the Uniform Policy. Brittney Hale seconded the motion. Motion passed unanimously.
